Summary of Change:

Please be advised that changes have occurred to the Glazier program as part of the program development cycle. The updated Glazier program will be implemented effective

September 1, 2018.

Rationale: At the request of industry, the Glazier program has undergone a program review to

ensure alignment with the current National Occupational Analysis (2012).

Details: Upon completion of the program update, the following changes will be implemented:

1. Occupational Description: an update to the current trade description in order to accurately capture the broad scope of tasks performed by a Glazier.

- 2. Recommended Education: removal of Science 10 to remove perceived barriers preventing entry to the trade.
- 3. Program Outline: addition of content from the NOA previously not captured, as well as resequencing of some content between levels to meet industry needs.

Standard Level Exams for this trade will be piloted with the new program and the launch will be announced at a later date with a follow-up OPSN.





Glazier Implementation

The Glazier Program Outline was revised in 2017 to ensure alignment with the current NOA (2012) and to address changes recommended by industry. As a result, the updated Glazier Program Outline reflects changes to the technical training sequencing, as well as the introduction of some new content. The gaps for apprentices are not significant, allowing for an immediate transition into the new program. See below for details.



According to the figure above, students with:


- Current Level 1 can transition straight into New Level 2 (and NL3 thereafter).
 - These students will experience Gap A (missing specific content) and Overlap A, repetition of other content.
- Current Level 1 and 2 can transition into New Level 3.
 - These students will experience Gap B (missing specific content) and Overlap B, repetition of other content.
